Explanation Notes:

i) Proposed increase of BID Targeted Rate

The current BID Policy adopted by Auckland Council in 2022 requires all BIDS programmes established before 2010 and currently receiving less than \$120,000 targeted rate grant annually (which includes the Association), are required to increase their total ongoing income received (including the BID targeted rate grant) to at least \$120,000 per annum by 1 July 2028. We are seeking to achieve this target progressively over the next few years.

i) The requirement for the Election of members to Mt Eden Village Inc is as follows:

There are up to eleven (11) vacancies for Association members.

The procedure for nominations as detail in rule 14 of the constitution is as follows:

Nomination of candidates for election

- shall be made in writing, signed by two Full Members of the Association and accompanied by the written consent of the candidate (which must be endorsed on the form of the nomination); and
- shall be delivered to the Secretary (Ken Choe) not less than seven days before the date fixed for the AGM, i.e. 5pm 10th October 2023.
