8. Indicative Budget for 2024/2025 financial year.

The Indicative Budget was tabled for discussion. Ken briefed the Meeting on a requirement by Auckland Council under its BID Policy that all BIDS have to achieve a minimum targeted rate income of \$120,000 by 1 July 2028. The Association has decided to achieve this by increments over the next four years to reduce the impact on members.

Moved: That the Budget (which is contained within the Business Plan) for the following 2024-2025 financial year to include a BID targeted rate grant amount of \$99,035, representing a 5.32% increase (or \$5,000) to the current BID targeted rate grant for 2023-2024 financial year (\$94,035). Further ask that the Albert-Eden Local Board recommend to the Governing Body the amount of \$99,035 be included in the Auckland Council draft 2024-2025 annual budget consultation process.
